## POLL RESULTS AT THE ANNUAL GENERAL MEETING HELD ON 29 NOVEMBER 2005

New World Mobile Holdings Limited ("Company") is pleased to announce the poll results in respect of the resolutions proposed at the annual general meeting of the Company held on 29 November 2005 ("AGM").

Reference is made to the circular of the Company dated 25 October 2005 (the "Circular"). Terms used in this announcement shall have the same meanings as defined in the Circular unless the context requires otherwise.

As at the date of the AGM, the total number of issued shares of the Company is 95,336,069 Shares, which was the total number of shares entitling the holders to attend and vote for or against the resolutions at the AGM ("Existing Shares"). Every member present in person or by proxy has one vote for every share of which he is the holder. There were no restrictions on any shareholders to cast votes only against any of the proposed resolutions at the AGM. At the AGM, poll voting was demanded by the Chairman for voting on all the proposed resolutions as set out in the notice of AGM. Abacus Share Registrars Limited, the branch share registrar of the Company, had acted as the scrutineer at the AGM for the purpose of vote-taking. The results of the voting are as follows:
